3. TERMS AND CONDITIONS FOR THE ISSUANCE OF THE NQR SOUND BOX

- a. The Merchant shall use the NQR code of his/her account linked to the NQR Sound Box issued by the T Bank for all transactions pertaining to the sale of goods and services at his/her shop.
- b. The Bank shall deliver the account statement as and when required.
- c. The Merchant will pay a monthly recurring charge of Nu. 100/- for a period of 2 years for the NQR Sound box availed from T Bank and the Bank will absorb the remaining cost. In case the Merchant decides to discontinue the NQR Sound Box, it can be done by giving a written notice of 7 days in advance to the Bank and paying the remaining monthly recurring charges of Nu. 100/- from the month of discontinuation to the last month of the 2 year period.
- d. The Bank shall not be liable for any loss or damage of the NQR Sound Box due to thefts and frauds that may arise in the premises.
- e. The Merchant is responsible for arranging a separate 4G-enabled SIM card.
- f. The Bank will provide a replacement for the NQR Bound Box only if there is a technical issue with the Sound Box device within 1 year from the date of issue, excluding damages resulting from:
 - I. Moisture or liquid penetration.
 - II. Physical damage, such as from a fall or impact.
 - III. Theft, unauthorized intervention, including repairs conducted by an unauthorized individual during the warranty period.
- g. Merchants will have to bear the cost of any spare parts including the transportation charges; however, T Bank will provide the spare parts.
